2021 saw the return of a more normal boating season. We were able to perform RVCC inspections. Details are in the RVCC Officer's excellent report. No face-to-face Bridge meetings or social events were held in 2021. The 2021 AGM was held on line using the Squadron's licensed copy of Zoom. We expect the 2022 Squadron AGM to be a face-to-face. The Squadron continues to participate in on-line courses. Details will be found in the Education Officer's Report

I attended the virtual National AGM. A proposed dues increase was approved. Planning for the 2022 National AGM is in progress. This face-to-face meeting will be held here in Toronto. I recently received a letter signed by Chief Commander Peter Bolton. This letter is a request for contributions to "support for major CPS-ECP programs/projects vital to the sustainability of our organization". The projects are:

- . improve landing pages for PCOC and Maritime Radio \$50k
- . complete financial dashboards for more info for financial officers \$15k
- . ensure functionality of the Membership renewal before 2022 \$25k

- . accept 3rd party payments for courses and course materials \$10k
 - . maintain Recognized Provider and Recognized Examiner data bases for Squadron/District use \$5k
 - . complete a thorough review of National Office building to develop an upgrade/maintenance plan \$5k
- Many of these projects are improvements to the new IT system.

This topic was discussed at the Bridge meeting held on November 18th. The Squadron's finances are in good shape. Our expenditures have been reduced because we have not been renting classrooms or putting on social events. For details, please refer to the Financial Officer's Report.

It was agreed that the Squadron should support the National Organization. However, The Bridge feels obligated to ensure that any contribution made will be used effectively. Development and implementation of the new IT system has been plagued with problems and delays. It was agreed that I would respond to the letter requesting more information to ensure that these projects will be properly managed and completed in a timely fashion. Assuming we receive a satisfactory response, I expect that the Squadron will make a contribution to one of these Projects. The Squadron Financial Officer assures me that the Financial Dashboards are urgently needed.

Finally, I regret to report the passing of Bill Alloway on October 18, 2021. Bill and his wife, Past Commander Carole Ann Alloway, joined CPS in 1999. Bill and I worked together instructing several courses. He was instrumental in getting the Squadron set up to use laptop computers and projectors for course presentations. He also assisted Carole Ann with preparation of

I rarely go out on the water without one of my many cameras. In late September I ventured out minus one of the above!

My boat is docked at Fifty Point Marina near Grimsby, SSW of Port Credit by about 25 nautical miles. The day was quite warm and sunny with a hint of sea mist. On the lake, however, the sea mist very quickly turned into a somewhat dense fog.

As a photographer I observed the way that light swirled and striated with the fog, and created a surreal and mystical aura. The shore was less than a km from my position, but virtually invisible. Thankfully, I had my trusty iphone, which has a fairly good sensor and optical system, and quickly began to shoot images of a nearby 30' sailboat. Members of CPS - a letter from Transport Canada

Transport Canada have changed the Tier 1 Policy regarding Flares or Smoke Signals on pleasure craft. This was made effective on November 9/21 and details just published are as follows: (To be reviewed in 5 years) The following is a condensed version of the issued document. For complete information you may check online at the Transport Canada website.

Tier 1 - Policy - Acceptance of Electronic Visual Distress Signals (eVDSD) in lieu of Pyrotechnic distress signals (smoke signal or flare) on Pleasure Craft.

Policy statement:

2.1 when carried with an approved smoke signal, TC recognizes that an eVDSD can be carried instead of all approved rocket parachute flares, multi-star flares, hand flares or a watertight flashlight if the electronic signal is determined to have:

a) met the requirements of the RTCM Standard 13200.0 by a Product Certification body or been accepted by the US Coast Guard

Any written operating instructions and warnings required by the RTCM Standard 13200.0 to be on the eVDSD shall be in both English and French - Instruction manuals required by the Standard must be available both in English and French.

Background: The Small Vessel Regulations currently require, amongst other things, that all pleasure craft longer than 6 metres, carry pyrotechnic distress signals unless:

b. they are operating on a river, canal or lake in which they can at no time be more than one nautical mile from shore: or,

c. they have no sleeping arrangements and are engaged in an official competition or in final preparation for an official competition.

7.2 Smoke signals and flares are hard to ship, store and dispose of in a safe and environmentally friendly way. Its also hard to find a course to learn how to use them correctly. As such Transport Canada began looking into alternative signaling devices.

7.3 In June of 2018, following extensive research, the RTCM published the RTCM Standard 13200.0 which lists the requirements for Electronic Visual Distress Signal Devices (eVDSD).

7.4 After consulting with marine stakeholders and Canadian search and rescue authorities, Transport Canada now recognizes eVDSD as an

approved alternative to traditional pyrotechnic distress signals

IN CANADA, PLEASURE CRAFT CAN USE eVDSD THAT ARE CERTIFIED TO THE RADIO TECHNICAL COMMISSION FOR MARITIME SERVICES (RTCM) STANDARD 13200.0 INSTEAD OF TRADITIONAL PYROTECHNIC DISTRESS SIGNALS,

This policy only applies to pleasure craft.

It requires that a TC approved signal be carried with the eVDSD for daytime alerting

It only allows eVDSD with documentation from an accredited product certification body, or the US Coast Guard, stating that it has been tested to and meets the requirements of the RTCM Standard 13200.0

Devices must be labelled with the statement "Complies with RTCM Standard 13200.0 for an eVDSD". If a device doesn't include this statement, it can't be used as an alternative to pyrotechnic distress signals.

THIS POLICY ADDS ADDITIONAL CHOICES FOR DISTRESS ALERTING AVAILABLE TO VESSEL OPERATORS. IT DOES NOT REPLACE THE ACCEPTANCE OF APPROVED PYROTECHNIC DISTRESS SIGNALS. THESE FLARES CONTINUE TO BE AN OPTION THAT MAY BE USED TO MEET THE REQUIREMENTS OF THE REGULATIONS.

Characteristics of eVDSD - An electronic signal that meets the standard will have:

..signal characteristic in the form of a 2-colour cyan (blue) and red-orange S-O-S light sequence

..near-infrared signal so it can be detected with night vision goggles

..an operating temperature range of -1 degreeC to +30 degreeC

..a storage temperature range of -20degreeC to +55degreeC

..an average effective intensity of at least 50 candela

..at least 2 hours continuous operating life
